## WISCONSIN STATEWIDE ELECTIONS NOVEMBER 2006

### WISCONSINITES' SATISFACTION AND INTEREST IN THE NOVEMBER ELECTION

#### Satisfaction with the way things are going today

The most recent Badger Poll shows that a majority (61%) of Wisconsinites are dissatisfied with the way things are going in the United States today and a majority of those who are dissatisfied reported that they are very dissatisfied. Closer to home, just over half of Wisconsinites say they are satisfied with the way things are going in the state of Wisconsin today. However, roughly three-quarters of those reporting they are satisfied said they are only somewhat satisfied (see Appendix for the table with subgroups).

Over a quarter of all respondents said they are dissatisfied with the way things are going in both the U.S. and the state of Wisconsin today, while about one fifth said they are satisfied with the way things are going in both the U.S. and the state of Wisconsin today. While 27 percent reported some level of satisfaction with the way things are going in Wisconsin, but not in the U.S.

### Interest in the upcoming election

When asked about the upcoming election, less than half of respondents reported that they have thought a lot about it, while one-third said they had given it some thought. However, among those likely to cast a ballot, 57 percent reported they have thought a lot about the election.

Approximately three-quarters of Wisconsinites said they were very likely to cast a ballot on November 7, 2006. However, based on past voting history for the previous gubernatorial race, respondents are likely over-reporting their tendency to vote. Only 59 percent of respondents said they voted in the last gubernatorial election in November 2002.

A subgroup of respondents who are the most likely to vote on election day was created by constructing an index from various questions. To qualify for the likely voter subgroup, respondents had to say they are registered to vote in the state of Wisconsin, know where people in their neighborhood go to vote, have voted in their local election precinct or district, reported voting in both November 2004 and November 2002, and are very likely to vote on November 7, 2006 (or volunteered they already cast a ballot by absentee balloting). Just over 52 percent of all respondents to the poll meet all the qualifications.

## Most important issues facing the people of Wisconsin heading into the election

Respondents to the Badger Poll reported that the top five issues facing the people of Wisconsin heading into the current election are:

- ✓ the economy and jobs (18%)
- ✓ health care (15%)
- ✓ taxes (11%)
- ✓ education (11%)
- ✓ and the situation in Iraq (10%)

In total, approximately 65% of Wisconsinites picked one of these five issue areas as the most important issue. The same five issue areas are also the top five among the subgroup of likely voters and among those who said they prefer incumbent Jim Doyle in the governor's race. Four of the five are also among the top five of among those who said they prefer Mark Green in the governor's race. Education was chosen less often by respondents who favored Green than were several other issues including: immigration and amending the State Constitution to define marriage.

## Corruption in Wisconsin state government

Just under 50 percent of Wisconsinites report that they have been paying some or a lot of attention to the corruption and scandals in state government. Further, approximately 60 percent feel that the level of corruption has remained about the same under Governor Jim Doyle (11 percent thought the level of corruption has risen, while 25 percent thought it has fallen while Doyle has been governor).

Overall, a majority of Wisconsinites believe that both the Democratic and Republican parties are equally to blame for the corruption problems in state government. Even among partisans a majority of Democrats (53%) and a near majority of Republicans (49%) believe that both the Democratic and Republican parties are equally to blame.

## THE GUBERNATORIAL RACE

The most recent Badger Poll indicates that roughly half of Wisconsinites prefer the incumbent Jim Doyle over challengers Mark Green and Nelson Eisman in the race for governor (see Appendix for the results among subgroups).

- ✓ Among all Wisconsinites Jim Doyle leads Mark Green by 14 percentage points.
- ✓ Among those registered to vote Doyle leads Green by 13 percentage points.
- ✓ Among those most likely to vote Doyle leads Green by 12 percentage points.
- ✓ Doyle has a 7 percentage point lead among men.
- ✓ Doyle has a 21 percentage point lead among women.
- ✓ Doyle has an 18 percentage point lead over Green among independents and people affiliated with a party other than the Democrats or Republicans.
- ✓ Doyle has a double digit lead among Wisconsinites ages 18 to 30, 45 to 59, and those 60 and over.

## Impressions of the candidates for governor

Just over 50 percent of Wisconsinites report that they have a favorable impression of Jim Doyle and roughly one-third report they have a favorable impression of Mark Green. The vast majority also say they do not know enough to have an impression of Nelson Eisman (the Green Party candidate for Governor). Jim Doyle's ratio of favorable to unfavorable impressions has remained fairly stable since earlier in the summer (June 2006), while Mark Green's ratio of favorable to unfavorable impressions has evened out since June. Currently approximately one-third of Wisconsinites say they have a favorable impression of Green, one-third say they have an unfavorable impression, and the remaining one-third say they do not know enough to have an impression of Mark Green.

## Issues that describe the gubernatorial candidates

The Badger Poll asked all Wisconsinites about their perceptions of the three candidates for governor. Respondents were asked which candidate they thought each of the six phrases most accurately describes. Among the three candidates not a single candidate received a majority on any of the phrases. However, incumbent Governor Jim Doyle was chosen the most often for four of the six phrases:

- ✓ Understands the problems ordinary people face
- ✓ Will balance the state budget
- ✓ Will improve access to health care
- ✓ and Will help improve the environment in Wisconsin.

Mark Green was chosen the most often for the following two phrases:

- ✓ Will keep taxes down for ordinary Wisconsin residents
- ✓ and Will help create jobs in Wisconsin.

### Jim Doyle's job rating as governor

While Jim Doyle's job rating as governor of Wisconsin is up slightly since June, it is still in the same pattern that his job rating has been in over the last three years – more Wisconsinites saying he has done a fair or poor job than say he has done a good or excellent job.

In fact, Jim Doyle's good to excellent ratings are higher than his fair to poor ratings for only three key subgroups: Democrats (67% positive to 32% negative), residents in SC WI/the greater Madison area (55% to 43%) and among residents in western Wisconsin along the Mississippi river (48% to 46%). Doyle also enjoys higher job ratings among respondents who are satisfied with the way things are going in Wisconsin today (59% good to excellent compared to 39% fair to poor).

The table below shows how the Governor's current job rating is viewed through the lens of partisanship for many people. Democrats give Doyle a 67 percent good or excellent rating, while only a 32 percent give a fair or poor rating. Republicans on the other hand only give Doyle a 16 percent good or excellent rating, while giving him an 80 percent fair or poor rating.

## How much difference does it make who is elected governor

A majority of Wisconsinites thinks that the choice of the person elected Governor this year will make a lot of difference. There are also majorities of among people registered to vote and those most likely to vote who think it makes a lot of difference who is elected Governor of Wisconsin this year. Sixty-four percent of Democrats feel that way compared to 49 percent of Republicans and 43 percent of independents and other partisans.

## THE ATTORNEY GENERAL'S RACE

Overall, Wisconsinites seem to be leaning towards Kathleen Falk as their choice in the race for attorney general. However, there is still a good chance this will be a competitive race right down to election day with 22 percent reporting they do not know who they favor (see Appendix for the table with key subgroups). Further, Falk's lead over Van Hollen is only five percentage points among the subgroup of likely voters, with 17 percent of likely voters reporting they still do not know who they prefer.

Predicting who will vote on election day is never a certainty and given the lower number of likely voters one should take caution when interpreting the results.

Overall, Kathleen Falk is leading J.B. Van Hollen for attorney general:

- ✓ by 15 percentage points among women
- ✓ by 6 percentage points among men
- ✓ by 46 percentage points among those age 18 to 29
- ✓ and by 16 percentage points among those age 60 and over.

## Impressions of candidates for attorney general

Majorities of respondents report that they do not know enough to have an impression of either Kathleen Falk or J.B. Van Hollen. The minority of respondents who gave an impression expressed a slightly higher favorable than unfavorable impression of both Falk and Van Hollen. Roughly 58 percent of those who have an impression of Falk say it is favorable and approximately 60 percent of those who have an impression of Van Hollen say it is favorable. However, for both Falk and Van Hollen, these favorable ratings are far outweighed by the majority of Wisconsinites who do not know enough to give an impression.

## THE U.S. SENATE RACE

The most recent Badger Poll indicates that Herb Kohl enjoys a substantial lead in his bid for re-election to the U.S. Senate – 69 percent of Wisconsinites prefer Kohl and 73 percent of those most likely to vote on election day prefer Kohl over his three challengers.

## Impressions of candidates for U.S. senator

As the table below demonstrates, large percentages of almost all key subgroups have a favorable image of Herb Kohl. Even more Republicans have a favorable image of Kohl than have an unfavorable image. For comparison, Kohl's Republican challenger Robert Gerald Lorge is largely not recognized by Wisconsinites – 91 percent said they did not know enough to give an impression of him when his name was presented without any party identification or connection to the senate race.

## THE CONSTITUTIONAL REFERENDUM ON THE DEFINITION OF MARRIAGE

The constitutional referendum to amend the Wisconsin State Constitution to define marriage as between one man and one woman is favored by approximately half of Wisconsinites (see Appendix for the table with key subgroups). Among the most likely voters the constitutional amendment referendum is favored by 52 percent. The amendment is favored by most, but not all key subgroups.

- ✓ Favored by 17 percentage points among men.
- ✓ Favored by 61 percentage points among Republicans.
- ✓ Favored by 21 percentage points among those who have a high school degree or fewer years of education.
- ✓ Favored by 54 percentage points among those who see the Bible as the literal word of God.
- ✓ Favored by 36 percentage points among those who do not know anyone who is gay.

Among the key subgroups that have more opponents to the amendment are:

- ✓ Women oppose it by 5 percentage points
- ✓ Democrats oppose it by 14 percentage points
- ✓ Independents and other partisans oppose it by 18 percentage points

## THE ADVISORY REFERENDUM ON CAPITAL PUNISHMENT

The advisory referendum to enact the death penalty in Wisconsin for persons convicted of first degree intentional homicide, if the conviction is supported by DNA evidence is favored by 59 percent of Wisconsinites and opposed by 38 percent (see Appendix for the table with key subgroups). The margin narrows among the most likely voters – 51 percent favor and 44 percent oppose the advisory referendum.

### HOW THE POLL WAS DONE

This BADGER POLL™ was conducted by the University of Wisconsin Survey Center as part of its ongoing program of research designed to benefit the research community and the people of Wisconsin. The Director of the poll operations is Chad J. Kniss, UW Survey Center. The Faculty Director of the Poll content is Professor Katherine Cramer Walsh, Department of Political Science, UW-Madison. The BADGER POLL™ is intended to be a "poll of record" for the state, investigating matters of concern to Wisconsinites including politics, culture, and their daily lives, adhering to the highest standards of polling methodology and rigorous independence.

Results shown here are based on 508 persons who were randomly chosen within households with working telephone numbers and interviewed between October 18 and October 26, 2006. Telephone numbers were generated by computer. Theoretically, results from this survey have a "margin of error" of a little over +/- 4%. This means that, had we asked every *potential* voter in Wisconsin, exactly these questions at the time the survey was conducted, there is only a one in twenty chance that the answers would differ by more than that in either direction from what we report here. There could be differences because of changes in question wording, events occurring in the meantime, or any of the practical difficulties involved in taking a scientific survey. Results based on subgroups are subject to a larger "margin of error". Results reported here are based on weighted data (weighted on gender and age groups).
